

# LAZBOY SUMMER SALE 2019 TERMS AND CONDITIONS



1. The following specific terms and conditions apply to La-Z-Boy Furniture Gallery Lazboy Summer Sale.

a. Start Date: 8.30am on 1st February 2019.

b. End Date: 12.00pm on 2<sup>nd</sup> March 2019.

c. Promotion Details: Discounts of up to 50% off selected La-Z-Boy products in-store\*, except for the exclusions noted in e and ei

d. Advertised featured products:

## 3. General Terms

The following general terms and conditions apply to all promotions and all sales of La-Z-Boy products during any promotional period:

a. Making a purchase during a promotion is deemed acceptance of these Terms and Conditions.

b. All promotional pricing discounts are off the normal recommended retail price and available during the promotion period while stocks last.

c. The Retailer may cancel, terminate, modify or suspend or recommence a promotion or the terms and conditions of any promotion at any time and for any reason without notice.

d. The Retailer takes no responsibility for any customer's inability to participate in a promotion for any reason.

e. Any decisions made by the Retailer in relation to a promotion are final and no correspondence will be entered into.

f. To the fullest extent permitted by law, the Retailer, its suppliers and licensors (including La-Z-Boy Australia Pty Limited) and any of their personnel (the "Relevant Parties") exclude all liability for any loss (including any damage, claim, personal injury, cost or expense) which is suffered or incurred by in connection with the promotion.
